

The Heart of Thorncliffe

MICHAEL GARRON HOSPITAL IS EXPANDING ITS REACH BEYOND THE HOSPITAL WALLS TO GIVE CHILDREN IN THORNCLIFFE PARK A HEALTHIER START IN LIFE.

This year in Thorncliffe Park, children seeing their family physician can walk out with a Healthy Kids Habits 'prescription' encouraging good sleep, more vegetables and fruits, physical activity, limits to screen time, and no sugary drinks. The handy tear-off pads are one strand of a growing health care initiative to prevent type 2 diabetes, on the rise in children as young as six years old. The prescription pads, matching posters, screening tools, and, soon, family activity sessions, are all part of "Begin Right. Eat. Play", a program developed by Lisa Sparrow, clinical nurse specialist, with Carolyn Hay, lead paediatric dietitian at Michael Garron Hospital.

The project received a grant by the Lawson Foundation, a family foundation focused on the healthy development of children and youth. "Their understanding of the connection between gestational and childhood type 2 diabetes is key," says Lisa. "Their philanthropy will benefit generations."

The project is being piloted with community and health providers in Thorncliffe Park, where rates of diabetes and gestational diabetes are the highest in the region.

"Thanks to community partnerships and our Family Doctor Residency program, we've developed education and practical tools for doctors, nurse practitioners and midwives," says Lisa.

"There is amazing uptake in the neighbourhood, because awareness about preventing diabetes has gained a strong foothold." -Lisa Sparrow

Project coordinator Meena Lalani understands the challenges and strengths of Thorncliffe Park. At 13, she and her family immigrated to Toronto and settled there. "Newcomers face barriers to care, such as poverty, post-traumatic stress disorder, and not knowing how the health system works," she says. "But there are organizations and community groups doing great work here. We've taken a participatory action approach, building the program with the community."

Meena spent year one meeting with residents, speaking with mothers with gestational diabetes, developing school mentorship programs, educating health care providers and engaging with faith groups.

The project became personal when she had her own blood sugar levels checked, and learned she was almost pre-diabetic at the age of 24, given her South Asian descent and shiftwork that affected her eating habits. Lifestyle changes have brought her levels within normal range.

"This program is very flexible and adapts to what already exists," says Alia Virjee, dietician with Health Access Thorncliffe Park, who has seen it easily tailored for different audiences. "And because they've trained practitioners from the community that serve all populations – from kids to youth to moms – there will be consistent messaging."

"It's always been about enabling people, and building something sustainable," says Meena. "I'm proud of the Hospital for taking this step. It's a proactive approach, using people's strengths to bring about innovative projects that can change the future for generations to come in Thorncliffe Park."



WHAT'S NEXT:

Thorncliffe Park is a vibrant and growing community with 5,000 children. However, these children have a higher than average rate of developmental delays and behavioural challenges. In fact, 30 per cent of patients at the Michael Garron Hospital Child Development Centre come from this neighbourhood. To support these children and families, in partnership with Michael Garron Hospital and the Toronto District School Board, Health Access Thorncliffe Park (HATP) opened a paediatric school-based outreach clinic in Thorncliffe Park Public School and Fraser Mustard Learning Academy in November 2017 serving children between birth and age 12. It's just one of the many services tailored to the needs of local residents offered by Michael Garron Hospital community partnerships.

The Heart of Having Your Life Back



The Garron family's \$50-million commitment — made in memory of their son, Michael in 2015 has enabled the hospital to purchase a wide variety of critical equipment over the past two years, including:

- equipment to repair trauma to large bones
- a diagnostic ultrasound unit
- 3D echocardiogram machines
- ventilators for the ICU
- a CT scanner
- patient beds
- a Holmium laser for minimally invasive prostate surgery
- a surgical spinal bed

Carolyn Rouse is grateful for the doctors and nurses who shepherded her through endometriosis surgery last November. She is also grateful for the actions of two complete strangers: Berna and Myron Garron.

> "The Garrons' gift gave me my life back. Because of them, the hospital acquired the gynecological laser that made my surgery possible," explains Carolyn.

Endometriosis is a progressive inflammatory disease where tissue similar to the inside lining of the uterus is found attached to reproductive, urinary, digestive and thoracic organs. It affects one in 10 women of childbearing age, and causes progressively painful periods, constant pelvic pain, low back pain, painful bowel movements, bloating, and painful intercourse.

"Endometriosis can rob you of intimacy, strain your relationships, impact your career and your ability to make and keep plans," says Carolyn. Since being diagnosed a dozen years ago, she has endured multiple surgeries, fatigue and pain.

Her disease reached stage four in 2014. Surgery provided some relief, but she was in constant pain.

Carolyn sought a surgeon who could tackle complex cases. In 2017, she met with Dr. Yoav Brill,



gynaecologic surgeon at Michael Garron Hospital, and one of a handful of gynaecologists in Canada trained in the painstaking surgery to excise the cysts, adhesions and nodules of endometriosis.

Not only did Dr. Brill have the skills to tackle Carolyn's case, the hospital had a new gynaecological laser, thanks to the Garron's landmark \$50-million donation in 2015. The couple's visionary generosity is transforming care across the hospital, funding the purchase of vital equipment.

"Endometriosis has been likened to an iceberg," says Dr. Brill. "Only 10 per cent is visible above the surface. If you simply melt the surface of an iceberg, it can still sink the Titanic. You have to remove it, and that's where the laser is quite helpful. It's very accurate and has little thermal spread, so you can operate around blood vessels, the bowel, the ureter, without doing damage."

"When I got the call telling me to come in for surgery, tears of relief streamed down my face," recalls Carolyn. After a nearly seven hour procedure, the pain she had been living with was suddenly gone. "It was amazing. I wake up every day grateful and happy. I feel a renewed sense of strength. I'm working, and enjoying my life.

"I couldn't believe my luck, being able to access such world-class care right in my neighbourhood."



WHAT'S NEXT:

This summer, funds from the Garron gift will support the purchase of a new 3T magnetic resonance imaging (MRI) machine to replace the hospital's aging MRI technology. The new MRI will cut scan times by up to half, diagnose conditions more accurately with significantly improved image quality, and provide patients with a much more comfortable experience.

In the future, the Garrons' gift will fund more equipment, an innovation fund, and the creation of the hospital's first research and education chairs.



The Heart of Safer Healthcare

MICHAEL GARRON HOSPITAL IS A LEADER IN QUALITY IMPROVEMENT AND PATIENT SAFETY. FOR CHIEF OF MEDICINE DR. JOHN ABRAHAMSON, IT'S A COMMITMENT THAT GOES BEYOND HIS DAY AT WORK.

Ensuring patients are safe and receive quality care is work that Michael Garron Hospital Chief of Medicine Dr. John Abrahamson champions each day in his role at the hospital and as a philanthropist. Together with his stepmother, Carol Kirsh, John supports the Abrahamson Family Fund, which funds quality improvement and patient safety initiatives at the hospital.

The need for this research is great: currently in Canada, one in 10 adults contract an infection in the hospital, and another one in 10 receive the wrong medication or an incorrect dose. Quality improvement enhances patient safety by improving protocols and practice, reducing the likelihood of physician error. But improving safety doesn't mean pointing fingers at caregivers — it means identifying issues with systems and processes.

"Care providers are good people doing the best job they can," says John, "but even good people make mistakes. Quality improvement is about fixing systems to make hospitals safer by reducing the likelihood of human error."

Over the past two years, the Abrahamson Family Fund has



supported students conducting research at Michael Garron Hospital to improve quality of healthcare delivery. Last year, student Mark Daubauras won the award for his project focused on "deprescribing," which is when drugs with risks perceived to outweigh potential benefits in a patient are discontinued.

Thirty percent of patients over 65 are prescribed more than five medications which leaves them four times more likely to have a hospitalization or fall related to their medications, and accounts for 10 per cent of all admissions to hospital. Reducing the number of potentially risky prescriptions is critical to keeping elderly patients safe.

Mark, a Canadian studying medicine in Ireland, was one of ten Irish medical students who spent the summer working with clinicians at Michael Garron Hospital as part of the John Bradley Clinical Research Certificate Program (JBCRCP). This collaboration between the University of Toronto and the Royal College of Surgeons in Ireland was supported by TD Bank Financial Group.

In part through its culture of quality improvement and patient safety, Michael Garron Hospital is acknowledged as a leader in quality by the medical community through designations including Exemplary Status from Accreditation Canada. And by adapting rigorous patient safety practices, Michael Garron Hospital outperforms other Toronto hospitals in reducing deaths, readmissions, length-of-stay, hospital-acquired infections, and the cost of care.

"It's very important to my wife and me to keep our family's history of philanthropy alive through our daughters," says John. "Giving is important, and if we can leave something behind — like healthier patients living longer lives because of safe, quality care — then it's all worth it."



WHAT'S NEXT:

Michael Garron Hospital is a key member of the Joint Centres for Transformative Healthcare Innovation — a group of Greater Toronto Area community hospitals engaged in a number of collaborative initiatives designed to improve patient safety and increase quality of care.

Michael Garron Hospital's commitment to research and innovation has been strengthened with the appointment of Dr. Jeff Powis to Medical Director, Quality, Operational Excellence, Research & Innovation. Under Dr. Powis' direction, Michael Garron Hospital will expand its research and innovation program, improving healthcare delivery at the hospital and beyond its walls.

The Heart of Our New Campus

THE KEN AND MARILYN THOMSON PATIENT CARE CENTRE IS THE CORNERSTONE OF OUR REDEVELOPMENT PROJECT. MODERN, BRIGHT & THOUGHTFULLY DESIGNED, THE NEW FACILITY WILL BE A SOURCE OF COMMUNITY PRIDE AND REFLECT THE QUALITY CARE AND WARMTH FOR WHICH MICHAEL GARRON HOSPITAL IS KNOWN.

Features include:

More private rooms

80 per cent of patient beds will be located in single rooms with space for families to spend the night

Chronic Disease Unit

Chronic disease is associated with social inequity and aging. The East Toronto community has a higher prevalence of high blood pressure and diabetes than the city average. Located on the second floor of the Patient Care Centre, the Chronic Disease Unity will co-locate the Chest, Kidney and Heart Centres into in one convenient location, making frequent visits more convenient and allowing clinicians to collaborate more easily on patient care.

Care

New mental health facilities

Ken and M. Myn Thomson Patier

The new Patient Care Centre will support the hospitals role as the mental health care hub for East Toronto and offer a healing environment for individuals with mental health conditions. The facility will include a 44-bed adult unit and our six-bed Slaight Family Foundation Child and Adolescent Inpatient Mental Health Unit. It will also incorporate a secure, open-air,



rooftop terrace with spaces for therapeutic programming.

Four levels of underground parking

New learning facilities, including a dedicated space for medical simulation

The existing campus will also see the addition of many new features. Enhancements include:

Construction of an outdoor community hub with spaces for play and cultural programming, and a welcoming main entrance to the hospital

Redesign of the Diagnostic Imaging department to improve patient experience, safety, and efficiency

Consolidation of many outpatient infant, child, and teen services into the new BMO Paediatric Care Centre

Upgraded child/adolescent outpatient mental health clinics

2021: Ken and Marilyn Thomson Patient Care Centre complete

2021-2024: Phase 2 construction, including demolition of A, B, C, and F wings; renovations to existing spaces; construction of a new front entrance and landscaping on Coxwell Avenue

2024: Campus redevelopment complete




