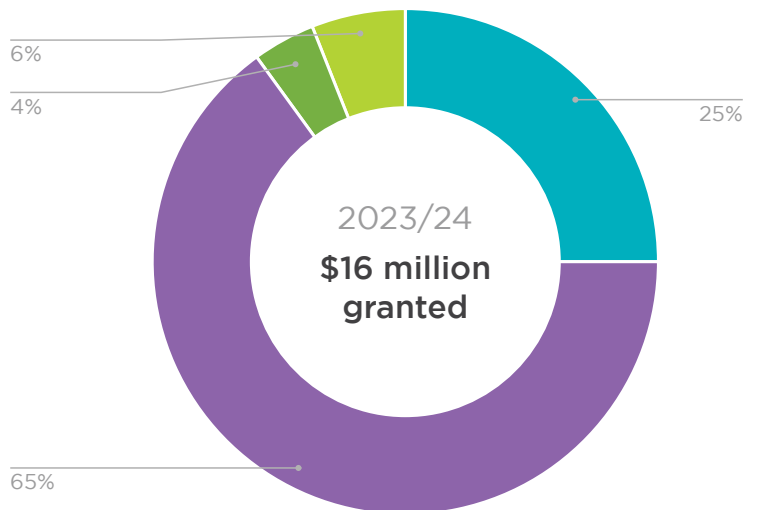
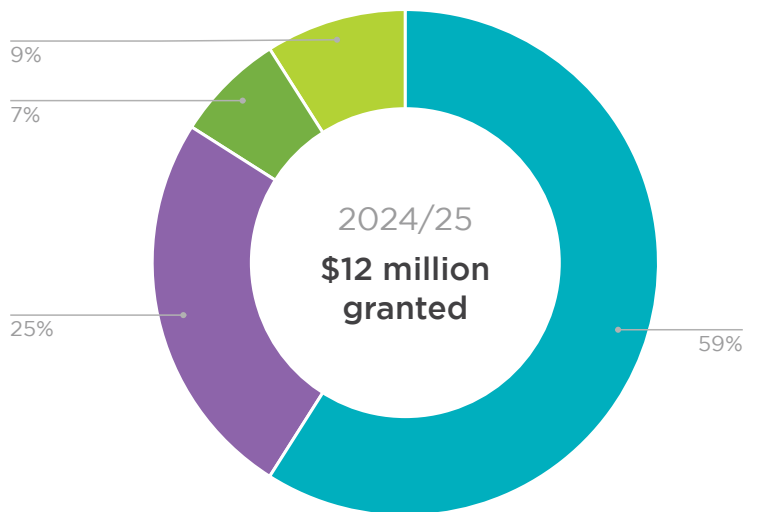

Strength in numbers

Over the last fiscal year, our supporters donated \$14.2 million to bolster the life-saving work of Michael Garron Hospital. These funds provide everything from state-of-the-art equipment and essential renovations to programs in our community, patient-oriented research and training for our award-winning team.

Speedy recoveries with robotic-assisted surgery

When Chris Dulny was diagnosed with prostate cancer, he came to Michael Garron Hospital to understand his options and seek treatment. He and his wife Mary Petryshyn soon learned that we are one of just four hospitals in Toronto with a surgical robot.

Thirteen years ago, we were the first community hospital in Canada to acquire a da Vinci Surgical System. This technology supports minimally invasive procedures, which are associated with less pain, fewer complications and shorter recovery times compared to traditional approaches.

Chris liked the sound of that.

A message from our leadership team

As Michael Garron Hospital's redevelopment continues, people are relying on us like never before. Our teams are responding with resilience and innovation.

Bolstered by support from throughout East Toronto and its surrounding areas, our shared progress underscores the importance of your ongoing investment. Donors like you are bringing hope to everyone we serve.

This fiscal was the third highest fundraising year for our foundation with \$14.2 million raised. In addition to supporting our hospital's areas of greatest need and emerging opportunities, these funds enable:

- Purchase of a new da Vinci Surgical System - Allowing us to expand our surgical robotics program so that patients with prostate, lung and kidney cancer can benefit from faster recoveries with less pain.

Among this year's highlights:

- Michael Garron Hospital was named Top Hospital, the highest rank in the *Toronto Star's* 2024 Readers Poll.
- Our hospital was recognized among Greater Toronto's Top Employers.
- Opening our BMO Child and Youth Centre to make for a more convenient experience for young patients and families going from appointment to appointment.
- A new partnership with the University of Toronto Scarborough Academy of Medicine and Integrated Health that invites local students to consider careers as health professionals in East Toronto. As part of this, a new Chair in Education for our hospital will highlight our strengths in academics.

In addition to keeping pace with the growth of our community, our hospital must always evolve with the speed of science and technology. Your philanthropy propels us forward.

Innovative technology and a supportive partnership

When tests pointed to early-stage prostate cancer, Chris Dulny and his wife Mary Petryshyn turned to Dr. Rajiv Singal, Chief of Surgery at Michael Garron Hospital.

“Because it was early-stage prostate cancer, I had treatment options. We had to get a bit predictive and figure out what would work best for me and my family,” Chris explains. “At the time, Rajiv was in the throes of moving offices and most of his stuff was boxed up. So instead of his usual props, he recreated parts of the male anatomy with papers, a stapler and a ruler. I liked him immediately.”

Gold-standard care

During Chris’ procedure, Dr. Singal controlled the robot’s instruments from a nearby console. The robot translated his hand movements in real time to bend and rotate tiny components, acting like a human hand but with a greater range of motion. At the same time, the robot provided magnified, 3D high-definition views, enabling Dr. Singal to see blood vessels, muscles and nerves in greater detail.

Now months into his recovery, Chris is working with a physiotherapist. “It’s wild. You have to retrain your body to do a lot of stuff,” he says.

“People ask why we didn’t go downtown and I’m all too happy to tell them about the quality of care we have right here in our own backyard,” says Mary. “Being able to go somewhere local has made everything easier and we’ve seen better outcomes because of it.”

Giving back

“When they heard our surgical robot was reaching the end of its serviceable life, donors like Chris and Mary came through for our hospital in a big way,” says Dr. Singal. “Thanks to our supporters, a new surgical system has enabled us to expand our robotic-assisted procedures to treat lung and kidney cancers. Today even more people are benefitting from our expertise in gold-standard, minimally invasive surgeries.”

Chris is fascinated by the technology. “I really see the robot as an example of human-led, tech power: innovations enabling humans to achieve great things,” he says. “If other families can benefit from our gift, possibly become donors themselves or spokespeople with their own stories – Mary and I are all for it. We need to help programs like this grow.” ♥

Preserving the health of older patients

A long-time Beaches resident, Robert was admitted to Michael Garron Hospital following a severe reaction to antibiotics. During his stay, he received daily visits from our Hospital Elder Life Program (HELP) team.

This specially trained group of staff and volunteers support older patients by ensuring their comfort and organizing activities to keep them mentally and physically active.

“It’s excellent for my morale,” says Robert after a week in our care. “HELP is very valuable. It’s the first time I’ve had anything like this in a hospital.”

Robert enjoys trading personal stories with the team, and he appreciates the radio and magazines they’ve lent him.

Tried-and-true

HELP is an established approach that has been making hospitals more senior-friendly for over 20 years. It’s been shown to prevent delirium and other critical issues associated with hospitalization.

Our hospital launched a tailored HELP program in August 2024. We currently offer it in two inpatient units and our Stavro Emergency Department, with plans for expansion to other areas. The team has aided 435 patients in just eight months.

Donors have contributed toward the cost of training volunteers and the purchase of supplies used to engage patients, such as tablets, lifelike robotic pets, jigsaw puzzles, crafts and much more. Deanna Rosolen, a HELP Activation Coordinator who oversees volunteers and supports patients, describes donor investment as “invaluable.”

The program, Deanna adds, is particularly beneficial for the many patients who have no visitors. “It’s such a good feeling when you walk in and a patient’s eyes light up because they have company,” she says.

Gratitude all around

HELP’s impact goes beyond patients, says Rosie Sears, a Behavioural Specialist who assesses patients and monitors their progress within HELP. “Clinicians tell us that HELP enhances the atmosphere for unit staff and patients alike,” says Rosie.

“Nurses and other staff are grateful that our team collaborates with them to elevate patient experiences. From assisting with food tray setup to playing board games, HELP’s presence allows staff to focus on their clinical tasks, where their specialized skills are needed.” ♥

From ambassadors to researchers

Community health ambassadors are deeply involved in their East Toronto neighbourhoods, where they help connect residents to health and community services. Ambassadors engaged in a health equity study co-led by Michael Garron Hospital and East Toronto Health Partners Ontario Health Team (ETHP OHT) are also helping with important research.

The study aims to assess social determinants of health – such as income, employment and food security – that may be affecting the health and well-being of east end residents.

A team of nine ambassadors from the Taylor-Massey and Thorncliffe Park neighbourhoods helped design a survey tailored to community members. They also received training on research and outreach methods.

Razia Rashed is a Taylor-Massey resident, Community Health Ambassador Lead with TNO – The Neighbourhood Organization, and Community Co-Lead at ETHP OHT. Flemingdon Health Centre and TNO, both ETHP OHT members, are partners in the study.

Razia says including community members in the research process “strengthens trust between the community and institutions, increases participation and ultimately leads to more meaningful and accurate outcomes.”

Razia played a key role in many aspects of the study outreach, from planning to engaging with residents. She took care to answer their questions about health equity while inviting participation in the survey.

Valuable insight

Sara Shearkhani, PhD, Evaluation and Equity Scientist with Michael Garron Hospital and ETHP OHT, co-leads the study.

“Survey responses will provide valuable insight into how social determinants of health affect residents, enabling our hospital, fellow ETHP OHT members and government partners to develop services that address their specific needs,” says Dr. Shearkhani.

In reviewing the results, Dr. Shearkhani says it's clear that collaborating with community health ambassadors as partners in research results in high-quality data and strong community participation. ♥

Fuelling discovery

By supporting research and innovation, donors make Dr. Shearkhani's health equity study – and other vital projects – possible. Their seed funding enabled the hiring of essential research administrative staff so that our hospital can apply for federal research grants independently, helping to secure over \$1.2 million in grants.

Case in point, Dr. Shearkhani's study represents one of three Canadian Institutes of Health Research grants our hospital has secured as the principal investigator. Philanthropy is helping us establish a nationally recognized, community-focused research program that solves challenges in East Toronto and beyond.

A lifeline for young people's mental health

When 19-year-old Charlotte was having suicidal thoughts, she came to our hospital for help.

She was soon introduced to Rachel Martin, a Social Worker in our Transitional Youth Program. Working closely with Rachel gave Charlotte the support she needed to connect with appropriate mental health care and make positive life changes.

"I've struggled my whole life and found it hard to ask for help. I thought I could handle things on my own, but I couldn't," says Charlotte. "With each appointment I started to feel a lot more comfortable."

The transition from youth to adult mental health services can be bewildering. When young people don't know where to turn for help for mental distress or substance use problems, they can reach a crisis that requires emergency care and leads to more enduring mental health challenges.

Easing the transition to adult mental health services

Our Transitional Youth Program helps young people aged 16 to 29 connect with adult mental health services. After being referred from clinics and programs within our hospital, clients typically join the program for three months. During this time, they receive evidence-based therapy, peer support and personal introductions to community programs and social services for longer term support.

As a result, many experience fewer mental health crises. Recent data shows a 57% reduction in clients' visits to our Stavro Emergency Department, as compared to six months prior to referral.

Sustained entirely by donors, the Transitional Youth Program gives hundreds of young people a bridge to better mental health.

After months of counselling, Charlotte feels more resilient and prepared to cope if things don't always go to plan.

"Now I feel like I have the tools to manage whatever comes my way," she says. "I'm happy to be alive." ❤️

Emergency department visits fell by **57%** for Transitional Youth Program clients



Delivering exceptional care in our Stavro Emergency Department

This year, our Stavro Emergency Department (ED) saw more than 106,000 patients, up nearly 23% from five years ago. Almost every patient is high acuity, meaning their health conditions are severe and complex.

Limited by facilities designed for less than half as many patients, our team finds innovative ways to ensure high-quality care. Impressively, our ED is among the province's top performers, with shorter wait times for our patients compared to the Ontario average.

"In the face of our strained healthcare system, we're proud of our team's ingenuity in adapting resources to deliver the highest quality care for our patients," says Dr. Kyle Vojdani, Chief and Medical Director of the ED.

Accommodating more patients when admissions surge

During cold and flu season, more patients need emergency care for respiratory illnesses. Their numbers hit record levels this winter, more than doubling the daily admission average.

To accommodate the surge, adjacent space was adapted to provide 12 temporary beds supported by team-based nursing. Before patients left the hospital, the team connected them with specialized care and community-based programs to ensure a smooth and safe transition home.

Expanded space for emergency care

Another example of the team's nimble approach came in March. To ease crowding in some of the ED's busiest areas, they created a Rapid Assessment Zone for people with non-life-threatening conditions. With capacity to treat 100 patients a day, it provides a quieter, more comfortable experience with shorter wait times.

This has resulted in improved patient and staff satisfaction and fewer instances of aggressive behaviour. "While emergency departments generally receive little favourable feedback from patients, an overwhelming proportion of comments we receive are positive," says Dr. Vojdani.

AI tool gives physicians more time with patients

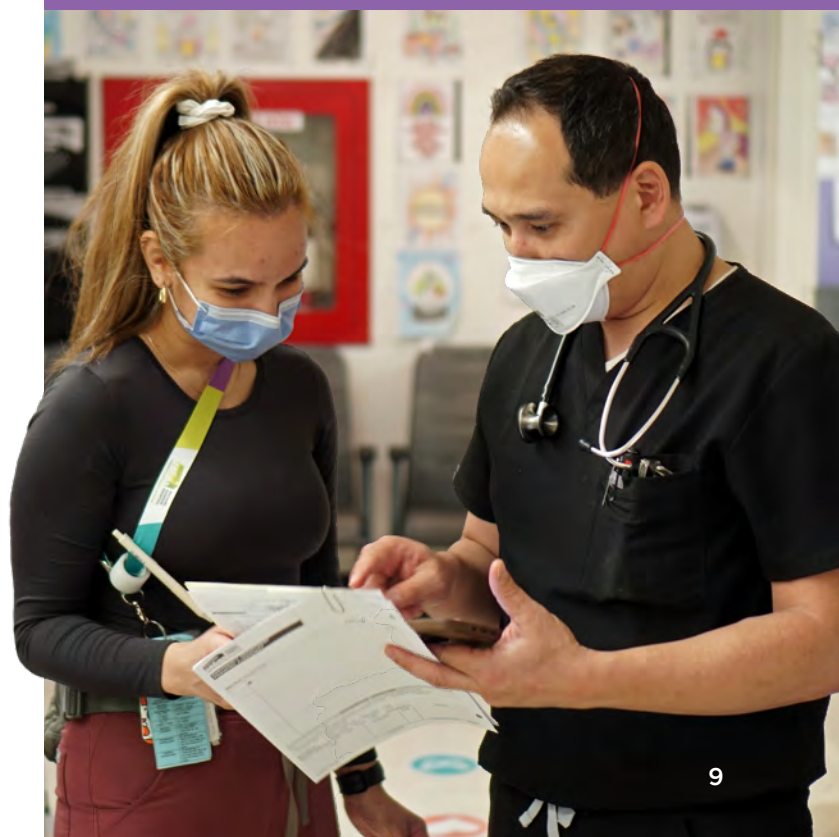
Our team embraces digital solutions and shares learnings to help other emergency departments implement similar technologies. ED physicians funded use of new software that made them some of the first in Canada leveraging artificial intelligence to avail time and attention for patient care.

With a patient's consent, a scribe tool creates notes during their conversation, allowing their physician to focus solely on the patient. The physician later reviews their charts and makes any necessary updates, saving up to two hours per shift. This time is used to see more patients and strengthen doctor-patient connections, all while reducing the risk of burnout associated with healthcare's growing administrative workload. ♥

Equipped to provide excellent care

Here's a look at how our patients benefit from equipment made possible by donors.

Our tiniest patients need close attention to get their best start in life. The team in our Neonatal Intensive Care Unit can respond swiftly to variations in babies' vital signs thanks to 14 new monitors that summarize complex clinical data in an easy-to-comprehend display. Also, 14 new incubators keep these fragile infants safe and warm in controlled micro-environments.

When illness or injuries prevent people from breathing on their own, they require life-saving mechanical ventilation that keeps their airways open, delivers oxygen and removes carbon dioxide from their lungs. Our hospital is the first in Canada to use Dräger Evita V800 ventilators – 44 of them in fact. These state-of-the-art machines provide patients with the latest respiratory therapies.

On our inpatient units, an updated call system enhances safety by making it easier for patients to request and receive help quickly. At the bedside, patients use a handheld device to communicate with the nursing team. They can speak or press buttons to indicate what they need, such as assistance with managing pain or leaving their bed.

These patients also have call buttons in their bathrooms. All calls appear on a nursing station console as well as team members' mobile devices, allowing them to triage and respond efficiently.

What's more, people with blocked and infected tear ducts now have a treatment option that offers shorter wait times and faster recoveries. New endoscopic equipment allows our ophthalmology team to perform minimally invasive surgery that causes less pain.

The additional equipment enables our team to operate on up to six patients a day with this technique. Previously, we had capacity for only two operations per day using a procedure that requires skin incisions near the eye, leaving a scar and requiring more recovery time. Providing this service means patients wait two to three months for treatment at our hospital, compared to a year or more at others in the Greater Toronto Area. ♥

Paediatric care under one roof

With the community's outstanding support of Michael Garron Hospital's ongoing redevelopment, we continue to enhance our facilities, bringing greater comfort and convenience to patients.

The BMO Child and Youth Centre is a perfect example. Opened in December 2024, the facility is a one-stop centre encompassing over 20 paediatric outpatient clinics that were previously located throughout our hospital. The centre's comprehensive team cares for newborns, children, teens and their families.

Parents appreciate being able to access multiple services in one spot, says Dr. Celia Atkinson, Chief of Paediatrics and Medical Co-Director of Maternal, Newborn and Child Services. "And you can't beat the fact that it is a modern, bright space that is really uplifting. When families walk in, they say 'Oh my, this is so beautiful.'"

The centre includes additional procedure rooms and spacious areas that better accommodate family members who accompany their children to appointments.

It also features a new Family and Newborn Clinic. Led by midwives, the clinic operates seven days a week to provide care for birthing people and newborns when timely primary care isn't available. It addresses semi-urgent concerns and routine checkups in the eight weeks following birth.

First-time parents Manon and Adrian received check-ups for their daughter Emilie, feeding support and more. "As new parents, it's a challenging time. It's been very helpful to have the clinic," Adrian says.

Redevelopment enters home stretch

Throughout the year, various hospital teams and services moved to renovated spaces in our legacy buildings.

Demolition of our outdated A, B, C and F wings in the summer of 2025 will create room for a beautifully landscaped outdoor community hub and our new main entrance on Coxwell Avenue, including a spacious U-shaped driveway to make drop-offs and pick-ups much easier.

Our original 1929 building (D Wing) is being renovated and will stand prominently as a link between our proud history and our exciting future. ♥

Building cardiac capacity in East Toronto

With work now underway to expand our Cedric E. Ritchie Cath Lab, Michael Garron Hospital is on the road to providing life-saving heart procedures to more patients every day. Donations totalling \$6.3 million are backing construction, which includes a second procedure room and a larger patient recovery area.

The cath lab team uses minimally invasive procedures to diagnose and treat heart disease. Expansion will improve access and pave the way for us to offer additional services as we continue to excel in cardiac care.

Greening our healthcare

Modern healthcare contributes significantly to greenhouse gas emissions and pollution. We’re taking action with green initiatives that are reducing our hospital’s impact on the environment.

“Our hospital is working to assist in the creation of low carbon, climate-resilient healthcare services,” says Schubert Martin, Director of Engineering Services and co-chair of our Environmental Sustainability Committee.

“Protecting our planet is ethically responsible and it can deliver tangible savings.”

Our efforts are highlighted in the committee’s first annual report, published in August 2024. They include a collaboration with other Toronto-area hospitals to reduce waste by replacing disposable surgical gowns and towels with ones that can be cleaned and sterilized. In another project, our hospital works with an equipment supplier to re-process and sterilize medical devices that would have been discarded after a single use, saving \$33,000 and diverting more than 280 pounds of trash from the landfill in the first four months.

Saving lives and easing emotional pain

Severe bleeding during pregnancy or after giving birth is a life-threatening emergency that can also cause lasting emotional trauma. To effectively treat obstetrical hemorrhage and mitigate distress, the right equipment and training are essential.

Our Family Birthing Centre team has both, thanks to the Impact Council, a group of young professionals who fundraise for Michael Garron Hospital.

Last year, funds raised at their events were used to buy equipment that helps our team respond quickly when patients experience obstetrical hemorrhage - a condition that affects up to 5% of births.

“Time is of the essence. How the team works together is crucial for how well obstetrical hemorrhage is managed,” says Christie Lockhart, Chief of Midwifery and Medical Co-Director of Maternal, Newborn and Child Services (MNC).

The new equipment enables clinicians to carry out life-saving blood transfusions as fast as possible. Other items support the insertion of breathing tubes and monitoring of patients’ vital signs.

Optimizing care

The Impact Council donation also helped nearly 60 Family Birthing Centre staff pursue training on trauma-informed care. This approach recognizes the effects of past emotional trauma and creates a safe environment for our patients.

Obstetricians, midwives, nurses, anesthesiologists and other staff participated in the training. “It was important to ensure everyone on our comprehensive team had the opportunity to build on their skills in this area,” says Dr. Elin Raymond, Chief of Obstetrics and Gynaecology and Medical Co-Director of MNC.

Dr. Raymond says the training is already helping improve patient care by heightening clinicians’ ability to sensitively care for people with trauma and to mitigate psychological harm.

Soon these skills will be shared beyond our Family Birthing Centre. Twenty staff who were certified as trauma-informed care trainers will go on to educate colleagues and learners across our hospital.

Putting the fun in fundraising

To support our hospital, the Impact Council hosts lively fundraisers. This year’s events included Good Laughs, Bowl at the Beach and East End Eats, which generated a total of \$120,000.

These proceeds are being invested in an artificial intelligence tool to help enhance patient experiences and treat more people. ♥

Sharing our commitment to equitable healthcare

Because everyone deserves the opportunity to thrive, the Moez & Marissa Kassam Equity Fund is removing barriers and building bridges to basic essentials, like quality healthcare. Their generous \$3.5 million commitment has been vital to our hospital's redevelopment, ensuring our facilities match our high standard of care. In recognition, the Moez & Marissa Kassam Food Court stands as a welcoming space for nourishment and connection.

Most recently, the Kassams established the Vital Venture Fund. The unique partnership brings donors together to hear directly from healthcare professionals and assist the hospital with critical equipment needs. Without this support, the purchase of needed items would be subject to competing demands on the hospital's strained budget.

"Equipment always needs to be renewed, and new technology and advances go a long way to benefit our community," says Dr. Tony Eskander, Chief of Otolaryngology. "The Vital Venture Fund supports clinicians and their patients by providing equipment that may otherwise go unfunded."

Now in its first year, the Vital Venture Fund has secured a broad array of equipment to enhance emergency services, cardiac care, lung function testing, breast cancer examinations and surgical services. Notably, it helped our hospital become one of the first in Canada to use High-Definition Intravascular Ultrasound, an innovative technology that allows doctors to see the insides of blood vessels in great detail. The Vital Venture Fund also paved the way for the imminent launch of Shockwave Therapy, which uses sonic pressure waves to break down calcium deposits in clogged arteries of the heart.

Our deepest thanks to Moez and Marissa for investing in our team's expert care by providing what we need to be at our best for patients. ❤️

Looking ahead

In the coming years, East Toronto will see significant growth with the development of Don Mills Crossing, Portlands and Golden Mile. Transportation improvements such as the Ontario Line and Eglinton Crosstown LRT will also add pressure to the system.
